The Sheltering Arms Foundation's mission is to invest in the lives of Minnesota's children so that they reach their full potential.



DEAR FRIENDS

Here are some highlights from the past fiscal year, July 1, 2023, to June 30, 2024. These accomplishments reflect the dedication of our staff, board of trustees, and numerous grant partners, all working tirelessly to help the children and families they serve thrive.

OUR GRANTMAKING

We provided \$579,000 in grant dollars to 56 organizations throughout Minnesota.

- **Advocacy:** 6 grants totaling \$60,000
- Early Childhood: 21 grants totaling \$224,500
- Wouth Development: 23 grants totaling \$255,500
- Episcopal Community: 4 grants totaling \$4,000
- **Collective Impact Partners:** 2 grants totaling \$35,000

Through this grantmaking, our grant partners served just over 10,000 children and families.

OUR GRANT PARTNERS

Each year, during the months of September and October, we have the privilege of meeting 1:1 with our grantees to discuss their grant program. Some of what we heard our nonprofit partners are struggling with include:

- Increasing costs to provide programming.
- 🏶 A lack of mental health therapies for children and youth.
- Workforce shortages, especially in the early childhood care sector.

We also heard that our grant partners adapt, thrive, and remain resilient. Sheltering Arms commends their hard work and dedication to working with the most vulnerable children during these difficult days.

OUR STRATEGY

A new strategic framework was created, identifying new possibilities within our grantmaking and advocacy efforts while remaining steadfast in our commitment to closing the opportunity gap for Black, Indigenous, and children of color.



There's magic in the air at Pillsbury House + Theater (PH+T) as budding young preschoolers are learning, exploring, and thriving with the support of talented teaching artists and a recent Sheltering Arms Foundation "Early Childhood Arts Integration" grant. One inspiring success story includes a young learner named David, who gained confidence and leadership skills due to his engagement in the artsfocused initiative. The most exciting news is that David has graduated and is now excelling in kindergarten!

PH+T, a cultural landmark in one of Minneapolis' most historic and diverse neighborhoods, houses the Pillsbury Early Education Center, an accredited learning center with a history of ensuring children like David are prepared for kindergarten. The arts-integrated learning programs offer a wide range of activities designed to spark curiosity, creativity, and learning confidence. Their approach is culturally diverse and attentive to each child's individual and distinct needs. The caring, licensed staff members share their expertise and experience in advanced training in early education.

This past year, PH+T brought resident teaching artists and its childcare program to deliver weekly classes in multiple arts disciplines, from origami to storytelling. These offerings enhance social/emotional, cognitive, and physical developmental milestones and develop creative expression in children ages 16 months to six years. Puppetry and music classes were added to the visual arts, movement, and theatre/storytelling classes. PH+T exceeded its goal of art classes and children served as it continued to nurture and grow an even more impactful program for neighborhood children.

Learning the game of lacrosse can be a powerful way for Indigenous youth to connect with a traditional sport, create their own identity, be a part of a team, and learn how the sport is rooted in their culture. The Indigenous Lacrosse Alliance (ILA) works alongside Indigenous organizations and communities to support children through cultural practices and teaching the love and historical significance of the sport. ILA's work centers on an inspiring mission to revitalize lacrosse in tribal and urban Indian communities with a vital goal of improving the well-being of Indigenous youth who traditionally face significant health challenges.

Sheltering Arms supports a partnership between the Fond du Lac band in Northeastern Minnesota and ILA through a "Community Development Program" grant, which operates at the Brookston Center on the Fond du Lac reservation. The groups meet three times a week for 1.5 to 2 hours, and each practice includes a meal with the belief that kids do better when their holistic needs are met. Each session starts with a circle up and setting of intentions for the day. This is followed by a sequential curriculum focused on skill development and small group games using traditional and modern versions of the sport.

Lacrosse originated in Indigenous communities and is part of the Indigenous cultural revival nationwide. The Fond du Lac program was developed to align with the Anishinaabe values of this community. In collaboration with Vue Farm, VEAP, Rise & Shine, and St. John's and Epiphany Episcopal Churches, St. Nicholas expanded their Food Share program, a local, neighbor-centered, volunteer-led mutual aid effort. Included in this initiative was the crucial need for school supplies as children returned to the classroom. With this expansion, they were able to reach more community members, especially children.

TRINITY EPISCOPAL CHURCH, EXCELSIOR Play Area \$1,000 Grant

Trinity Episcopal Church Excelsior built a playground to benefit low-income children in south Excelsior. This area consists of highdensity low-income apartments with an estimated 500 children living in the area, which had no other green space to provide a healthy and safe play area.

ADVOCACY

Empowering parents is at the heart of Family Wise Services' new advocacy initiative. It coaches parents to develop and share their voices at every level of community decision-making and family support. The organization's Parents As Leaders program helps parents and caregivers build their advocacy skills, share their stories in public settings, and positively influence policy in child welfare, children's mental health, and early childhood education.

Grant funding from Sheltering Arms enabled Parents As Leaders to bring on an additional staff member to lead the advocacy activities and training for 21 participants, helping them find their voice on issues that reflect their lived experiences. For example, one transformational participant's success story celebrates the progress made by an inspiring parent who faced struggles advocating for her son. Through her journey, she developed her personal story to help communicate what it is like to walk in her shoes as she engaged with and educated others, including elected officials.

Sheltering Arms Foundation grant support also includes building a curriculum and coordinating training that offers education around legislative processes, advocacy, storytelling, media relations, and program development. Partners include the Minnesota Coalition for Targeted Home Visiting, the United Way's policy team, the Department of Human Services, and numerous others.




